Introduction

The purpose of this document is:

- To define and record those functions specifically reserved to the Board of the Financial Ombudsman Service Ltd ("the Board") pursuant to the Financial Services and Markets Act, as amended by the Financial Services Act 2012 ("the Act").
- To define, and record the delegation of certain functions of the Board to the Chief Ombudsman and the Executive of the Financial Ombudsman Service ("the Executive") and the Executive's powers of further delegation.

The power to effect such delegation is derived expressly from section 225(2) and Schedule 17, paragraph 3(4) of the Act and implicitly from the Act establishing the Scheme Operator and under the operation of Article 22 of the Articles of Association of the Financial Ombudsman Service Ltd.

The Board has established sub-committees pursuant to Article 22 to carry out specific functions, including delegated functions, where appropriate. It currently has an Audit Committee and a Nomination and Remuneration Committee; their functions are prescribed in their respective terms of reference.

Notwithstanding such delegation, the Board remains accountable for all of its functions, including those delegated to the Executive, and will therefore receive information about the exercise of delegated functions from the Executive, in order to maintain a monitoring role.

All functions recorded as delegated in this Scheme of Delegation can be reassumed by the Board at any time. The Board expressly reserves the right to deal with any matters, whether generally or exceptionally, previously delegated.

This Scheme of Delegation does not address all the responsibilities of the Board created under the Act, as amended by the Limited Liability Partnership Regulations 2001, the Consumer Credit Act 2006, the Tribunals and Enforcement Act 2007, the Payment Services Regulations 2009, the Financial Services Act 2010, the Electronic Money Regulations 2011 and the Financial Services Act 2012, or elsewhere.

All functions of the Scheme Operator which have not been specifically reserved to the Board by virtue of schedule 17, paragraph 3(4) of the Act, or delegated in this Scheme of Delegation, (to include, for the avoidance of doubt, all and every function involved in the administration of the scheme by the Scheme Operator, pursuant to section 225(2) of the Act, and any function reasonably incidental to it) may be exercised by the Executive on behalf of the Board.

The Executive may itself further delegate any of its functions as it considers appropriate either fully or under the general supervision and control of the Executive to any employee or officer of the Company, or to any professional or technical advisers or other persons that the Executive considers to be appropriately skilled.
